By confirming this proposal, you confirm that you took note of the content of the General Conditions and the Acceptance Conditions as stipulated below and that you have accepted these General Conditions and Acceptance Conditions.

With exemption to the above, vessel visiting the Port of Gibraltar will be subjected to pay a Marpol fee as part of their calling dues. This fee is calculated on the basis of the vessels GRT by the Gibraltar Port Authorities and will provide the customer with a maximum free discharge volume (m3) of Marpol Annex I (bilges/sludge) & Annex V (Garbage) within a stipulated period of time.

##### Sampling

- ✓ Vessels inspected by the GMA on behalf of the GPA in relation to NONE COMPLIANCE of EU Directive 2000/59 and made to deliver waste oil will be charged in accordance with schedule 5.0 & 1.2-1.4 plus 100% extra charge pending barge or facility availability.

#### **Payment terms**

- ✓ Invoices will be submitted based on outturn figures discharged together with its appropriate barging rate. Credit notes will be produced based on outturn figures and on receipt of payment the following shall apply;
- ✓ Payment received within 30 days of Invoice date will be Credited 10%
  - *(Note: No Commission on barging outlay)*
- ✓ Payments received over the stated 30-day period will not attract any commission
- ✓ "No" services will be provided to vessels whom Agents have invoices in arrears of 30 days
